

Privacy Policy for Community Action Partnership of Orange County (CAP OC)

Effective Date: February 6, 2025

At Community Action Partnership of Orange County (CAP OC), we respect and prioritize your privacy. This Privacy Policy outlines how we collect, use, disclose, and safeguard your information when you engage with us, whether through our website, events, donations, text messaging, or other services. By interacting with CAP OC, you consent to the practices described in this policy.

1. Information We Collect

We may collect the following types of information:

- a. Personal Information
 - Name, email address, mailing address, and phone number.
 - Payment information for donations (processed securely through third-party payment processors).
 - Information you provide when signing up for events, newsletters, or volunteer opportunities.
 - Demographic information and preferences when voluntarily shared.
- b. Non-Personal Information
 - Browser type and device information.
 - IP address and geolocation data.
 - Website usage data collected through cookies and tracking technologies.
- 2. How We Use Your Information

We use the information we collect to:

- Process donations and provide donation receipts.
- Communicate updates, news, and upcoming events.
- Manage volunteer and program participation.
- Analyze and improve our services and outreach efforts.
- Comply with legal and regulatory obligations.

3. Information Sharing and Disclosure

We do not sell your personal information. We may share your information in the following ways:

- With Service Providers: To facilitate services such as payment processing, email distribution, and website hosting.
- Legal Compliance: When required by law or to protect our rights, privacy, safety, or property.
- With Your Consent: When you explicitly authorize us to share your information.
- 4. Security Measures

We implement reasonable administrative, technical, and physical safeguards to protect your personal information. However, no data transmission or storage system can be guaranteed to be 100% secure.





5. Your Privacy Rights

Depending on your location, you may have the following rights:

- Access and Correction: Request access to or correction of your personal information.
- Deletion: Request the deletion of your personal information.
- Opt-Out: Opt-out of marketing communications at any time by following the unsubscribe instructions in our emails or contacting us directly.

CAP OC does not knowingly collect personal information from children under 13 without parental consent. If we learn that we have collected such information without verification of parental consent, we will take steps to delete it.
